



International Women's Day – Women Working in Law

In celebration of International Women's Day 2022, several lawyers at Lester Aldridge share their experiences as females working in the law. Here's what they had to say:

"I am a solicitor in our residential property department and fortunately this is an area which has always had a good mix of men and women. There has, however, been a definite shift in the number of women in senior roles over the years and this is certainly something that has increased. When I first qualified as a solicitor there was only one female partner out of eleven in the firm I was at and the idea of having aspirations of a successful career and a family were incomprehensible. In fact, in the early days, I was once told by a male partner that he would never employ a woman in her thirties as she would inevitably leave to start a family!

"Thankfully these views are now changing and women are encouraged to take on more challenging roles. After working for many years at a City law firm, I decided to take a career break and focus on raising my two small children. I was worried that this would have a negative impact on my career, but on the contrary, it has been viewed as a positive – it shows strength of character, prioritising what's important, and not being afraid to take risks. I am fortunate enough to work for a fantastic firm like Lester Aldridge who understands the benefits of flexible working and work/life balance, but also that women are excellent multi-taskers who can run home life and million-pound transactions in unison. The firm encourages and drives us to do well and succeed. The level of support here is unparalleled in comparison to anywhere else I have ever worked.
